

### Featured Resource: Texas Workers' Compensation Manual

Workers' Compensation is an area of law that personal injury litigators handling cases involving workplace injuries and deaths, attorneys with a general practice, labor & employment lawyers, and attorneys with a practice primarily in Workers' Compensation deal with on a regular basis. It is also an issue that workers or their surviving family members may be forced to face following an on-the-job injury or death. His title is written by the attorneys of Austin law firm Flahive, Ogden & Latson and published by Post Hoc Press. Written for a broad audience to include attorneys, employers, insurance company personnel, healthcare providers, court personnel, government employees, etc., this essential manual is detailed, full of info, and is an essential source and great reference for its readers. The primary sections of the book are: the Texas Labor Code; Summaries of Select Court Case Decisions; Summaries of Select Ap-

peals Panel Decisions; Division of Workers' Compensation Rules; an Appendix containing several other key rules and statutes; and other handy charts and useful information. This edition is updated to reflect the current state of this area of Texas law. It is user-friendly with a general table of contents and index as well as a detailed table of contents for each chapter. Unlike much of the Law Library's materials, it is not published on-line. 
### **Technology Corner**

This Month's Featured Technology: The New Law Library Page on our Website

This month, we are going to focus on all of the items on our website and specifically what is on our Law Library page. First, go to our website at www.fortbend.lib.tx.us. This is the website for the entire Fort Bend County Library system. Other branch information is also located here as well as our online catalog where you can search what the Law Library has as well as the rest of the system. There are three different ways to get to our page. First, click on "Location/Hours" and select Law Library. Second, scroll down and select the big red "Law Library" icon. And third, select "Law Library" under "Research." On our page, we have a lot for you to see and access.



You can get access to our online databases from home, such as Gale Legal Forms Library and Legal Information Research Center. Both can be accessed by your library card. ### Civil Litigation/HOA Law

S-G Owners Association, Inc. v. Lurdes Sifuentes, 562 S.W.3d 614 (Tex.App.-Houston [1st Dist.] 2018, reh'g. denied): Appellee/ Defendant homeowner faithfully paid her homeowners' association annual assessment fees from the time she purchased the home in 2006 through 2013. She experienced financial difficulties in 2014 and was unable to pay. In 2015 she contacted the HOA in an attempt to pay the past due amount and square her account, but the HOA would not talk to her. So, she sent a check for \$2,000 to the HOA, but they would not accept it because they had referred the case to their attorneys. She contacted the attorneys more than once to try and work things out, but they never got back with her. They filed suit against her seeking to recover the past due fees and to foreclose the lien they had put on her home. Following a bench trial in the County Court at Law of Harris County a take-nothing judgment was entered in favor of Defendant. The HOA filed a request for the Court to enter findings of fact and conclusions of law. The Court requested the parties file proposed findings of fact and conclusions of law. Neither the Court nor the parties filed such documents. Because the HOA failed to file a Notice of Past Due Findings of Fact and Conclusions of Law it waived any complaint in this regard on appeal. The HOA also made a factual insufficiency complaint on appeal asserting that the facts supporting their case were undisputed and thus they were entitled to judgment in their favor. Their burden on appeal was to show that the Court's adverse finding was contrary to the great weight and preponderance of the evidence. The Court of Appeals pointed to the lack of admissible evidence brought by the HOA in regard to the past due account and that the Appellee had testified to not receiving correspondence from the HOA about her account. The Court as factfinder had the power to weigh the facts and evidence presented to reach its conclusion. The Court of Appeals affirmed the take-nothing judgment. An interesting opinion out of a Houston Court of Appeals that is worth reading by defendants, plaintiffs, and courts that deal with these types of lawsuits.

#### Criminal Law

• Lesley Diamond v. The State of Texas, 561 S.W.3d 288 (Tex.App.-Houston [14th Dist.] 2018, pet. granted): Appellant/Defendant was convicted of misdemeanor DWI. After receiving a report from the Texas Forensic Science Commission concerning the self-report by an analyst from the HPD crime lab that it had violated quality control documentation protocols, she filed an application for writ of habeus corpus alleging that the State had suppressed favorable evidence in violation of her due process rights. The habeus court denied her petition and she appealed contending that the habeus court erred in concluding that the undisclosed evidence is not favorable to the defense or material to the jury's verdict under the *Brady* case. The Court of Appeals concluded that the undisclosed evidence is material to the jury's verdict and favorable to Defendant and thus reversed the trial court's order and remanded.
