## Featured Resource: Texas Business Litigation

New to the collection is *Texas Business Litigation* from the Texas Lawyer. At the Law Library, we have been having a lot of people finding themselves in a business litigation suit with or without a lawyer. Many times we find it dealing with small businesses and various subcontractors. While we have some guides on this topic, this guide focuses specifically on these issues. The treatise from 2019, now in its third edition, breaks down each area of business litigation in chapters by subject. Topics include Alternative Dispute Resolution, Antitrust, Bankruptcy, Damages, Employment Law, finding Expert Witnesses, Fraud and Negligence, Business Divorce, and issues in E-discovery among others. The guide is edited by Sofia Adrogue and Caroline Baker, both attorneys having more than 20 years experience in the field. Many contributing authors also have varied and extensive experiences in the chapters they



write. The guide has an extensive table of contents and index. Make sure to look at the "Practice Pointers" in the guide as they may include some useful information from the editors that are not in the main text. The book is in print ONLY but copies can be made for \$0.10 a page. We also have scanners where you can email a portion of the book in PDF for free. We recommend using this guide in tandem with another source like *Dorsaneo's Texas Litigation Guide*, which will have forms that this treatise does not have. ## **Technology Corner: Online Family Law Materials**

Family Law is a significant portion of what bring patrons to the Law Library, be they attorneys practicing in this field or *pro se* litigants dealing with their own case. The Law Library has substantial online materials available via the legal databases and other materials on our patron computers. This column outlines these materials which include statutes, case law, practice guides and treatises, and forms. The Westlaw legal database is on patron computers 1-4. A general search on Westlaw will yield responsive materials in many categories including case law for all appellate courts in Texas (as well as the courts of the other 49 states and the Federal system if applicable), the Texas Family Code, practice guides and treatises such as the *Texas Practice Guide:* Family Law and the *Texas Practice Series Handbook of Family Law*. Westlaw is also where you will find the online version of the esteemed *O'Connor's* series including: Family Code Plus; Family Law Handbook; and, Family Law Forms. Lexis Advance (on patron computers 4-6) also provides many of the features that Westlaw does such as case law and statutes. Lexis also has

an in-depth practice guide, *Texas Family Law: Practice & Procedure* that provides detailed information and forms. The *Texas Family Practice Manual* and the accompanying forms (published by the State Bar of Texas) are in a desktop folder on all of the patron computers. Not exclusive to the Law Library but definitely worthy of mention is the webpage <a href="https://www.texaslawhelp.org">www.texaslawhelp.org</a>. **Texas Law Help** is an invaluable resource for information and forms on many aspects of family law. It is geared toward *pro se* parties and we use it extensively to assist these patrons. The materials from all these resources can be printed, downloaded, and/or e-mailed to you. The Law Library has a lot to offer in Family Law both online and in our print collection that we are proud to offer to our patrons. #### Criminal Law—Homicide/Solicitation—Abortion

The State of Texas v. Jason Dean Hunter 606 S.W.3d 836 (Tex.App.-Austin 2020, reh'g. denied.): State brought a pretrial appeal of the order quashing one count of the indictment. Defendant/Appellant was charged with solicitation to commit capital murder, a first degree felony. This indictment was based on text messages he sent to his girlfriend telling her to get an abortion. (Penal Code §15.03, criminal solicitation; and, Penal Code §19.03(a)(8), capital murder of a child under 10). Defendant filed a motion to quash contending that the indictment failed to allege an offense and violated his constitutional rights. The Court of Appeals noted that the District Court was correct in finding that the claimed offense that was being solicited provided exclusions to the applicability of 19.03(a)(8) in relation to actions by a mother in regard to her unborn child (essentially an exception for medical and pharmacological terminations of pregnancy). The Court discussed "legal impossibility", i.e., that the conduct solicited actually has to be capital murder....the offense has to be cognizable under Texas law. The Court of Appeals concluded that under Texas law the mother would not have committed an offense and thus the Defendant could not have solicited an illegal act. The trial court's quashing of this count in the indictment was thus affirmed.

#### Criminal Law—Search and Seizure—Cell Phone

Jerel C. Igboji v. The State of Texas, 607 S.W.3d 157 (Tex.App.-Houston [14th Dist.] 2020, pet. filed): Appeal out of Fort Bend County following Defendant's/Appellant's conviction for aggravated robbery for which he was sentenced to 17 years in the TDCJ. Defendant raised one issue on appeal: that the trial court erred when it denied his motion to suppress evidence obtained from the warrant-less seizure of his cell phone. Case arose out of a late night robbery of a KFC in Stafford. Defendant was an employee. A few days after the robbery the investigating officer contacted Defendant about making a formal statement and went and picked him up. At the station the officer took possession of the cell phone and two days later obtained a warrant to search it. Defendant was arrested a month later. Prior to trial he filed a motion to suppress evidence obtained from the warrantless seizure of his phone claiming that it violated his 4th Amendment rights which was denied following an evidentiary hearing. In a lengthy opinion the 14th Court of Appeals analyzed the case, finding among other things, that the Defendant did not voluntarily give the phone to the police, that the exigent circumstances exception did not apply, and that the admission of evidence obtained from the phone was not harmless error. Thus the conviction was reversed and remanded for a new trial. Dissenting opinion argued for the applicability of the exigent circumstances exception for justifying the seizure.

#### Family Law—Child Support/Modification—Military Benefits

In the Interest of K.M.B. and P.J.B., Minor Children, 606 S.W.3d 889 (Tex.App.-Dallas 2020), no pet. h.): Trial court ordered an increase in Father's/Appellant's child support obligation. Issues on appeal were: trial court improperly included his military allowances in calculating net resources for child support; that the court abused its discretion in finding a material and substantial change in circumstances justifying the modification; and that an award of mother's attorney's fees was an abuse of discretion. Court of Appeals agreed with trial court's finding that the military's base housing expense and base allowance for subsistence are in-kind benefits that increase the Father's income and thus must be included in the definition of resources and the calculation of his child support obligation. The other issues were also resolved against the Father. Trial court judgment affirmed.


## **Librarian Musings: Opening Procedures and Guidelines**
